PUBLISHER'S PREFACE

In the name of Allah, the Most Merciful and Compassionate. I bear witness that there is no god but Allah, alone without partners, and that Muḥammad is his servant and Messenger. I invoke the blessings of Allah and His peace upon His final Messenger, Muḥammad, his family and Companions, along with all those who follow them in goodness till the Day of Rising.

The primary objective of the Noble Qur'an, as the timeless book of guidance from Allah, is for people to understand and reflect upon its meanings. Allah says, "[This is] a blessed Book which We have revealed to you, [O Muḥammad] that they might reflect upon its verses and those of understanding would be reminded" (Qur'an, 38:29). In another place, Allah censures those who fail to reflect upon the Qur'an, and suggests it is disease in their hearts which caused their indifference towards His blessed Book. Alongside these works, it was thought appropriate to bring to light a number of works from the Qur'anic sciences (*'ulūm al-Qur'ān*) genre, which serve as an important prerequisite before undertaking the study of any particular exegesis (*tafsīr*). In this regard, Turath decided to abridge *Mukhtaṣar al-Itqān* of Ṣalāḥ al-Dīn Araqān, which

is itself an abridgment of Suyūṭī's monumental *Al-Itqān*. This relatively short work, due to its conciseness, is perfectly suited as an elementary work in this area, and we are hopeful it will serve well to precede our forthcoming publication of the acclaimed *Ulūm al-Qur'ān* of our beloved shaykh Mufti Muhammad Taqi Usmani.

I would like to thank my dear beloved friend Dr Mufti Abdur-Rahman Mangeria, director of White Thread Press, for introducing me to this work and the translator.
